



PISTOL AUSTRALIA INC.

CHARTER FOR THE NATIONAL REFEREE COUNCIL

It is the purpose of this Charter to provide Pistol Australia (PA) with the rules governing the formation and management of a standing sub-committee within the structure of PA.

1. **Name:** The National Referee Council (NRC).
2. **Objectives:** To develop, instruct and qualify PA range Officers, National Judges A and National Judges B.

To obtain recognition of Australian Judges at the highest levels of International shooting.

3. **Council:** The Council will consist of a maximum of eight (8) persons, a Director and the ex-officio member.

Council members shall be elected for a period of two (2) years.

Council members shall be determined by election at the Annual General Meeting of Pistol Australia Inc.

No more than two members may be elected from any one State.

Nominations will be accepted from any member of PA, provided that the person so nominated is a National Judge. Retiring council members may nominate for reappointment.

4. **Director:** Responsibility for the management of the NRC will be vested in a Director including the responsibility to propose or recommend amendments to the regulations to this Charter for approval by the PA Management Committee.

The Director shall be elected for a period of three (3) years.

The position of Director shall be determined by election at the Annual General Meeting of Pistol Australia Inc.

Nominations will be accepted from any member of PA, provided the person so nominated is a National Judge A.

5. **Finance:** To be provided by:

- i. PA
- ii. Other sources

6. Special Clause:

At the 1990 Annual General Meeting of Pistol Australia Inc. there will be an election of four (4) Council members for a period of two years. Then there will be an election from the remaining candidates of four (4) Council members for a period of one year. From the day after the 1990 Annual General Meeting this clause is repealed.

REGULATIONS

1. **Aim:** To achieve the objectives set out in the NRC Charter by:

- 1.01 Conducting referee clinics and seminars;
- 1.02 Monitoring the activities and assessing the capabilities of PA Range Officers and particularly National Judges A & B;
- 1.03 Promoting and maintaining a satisfactory level of organised refereeing at all National and Association controlled pistol shooting events;
- 1.04 Obtaining recognition of Australian National Judges at the highest levels of refereeing offered by international shooting bodies.

2. **Management:**

The Director shall be responsible for:

- 2.01 The overall management of the NRC;
- 2.02 Ensuring the standards for the training and accreditation of referees is such as to facilitate the recognition sought in point 1.04;
- 2.03 Maintaining an up-to-date Register of all NRC accredited persons;
- 2.04 Ensuring the proper conduct of NRC sponsored activities;
- 2.05 The development and conduct of examinations for NRC accreditation;
- 2.06 The development of a program to ensure all NRC accredited persons are kept aware of and conversant with new and changed events as appropriate to their level and qualification;
- 2.07 The development of assessments on new or changed events or regulations for submission to PA Management;
- 2.08 Submitting timely reports on NRC activities to PA Management, state Secretaries, NRC members and the *Australian Pistol Shooters Bulletin*;

- 2.09 Submitting within 30 days of any NRC activity that involves expenditure in excess of \$100.00 a detailed report on the prescribed form, to PA Management;
- 2.10 The development of a budget for the NRC for timely submission to PA Management;
- 2.11 Report to PA Management on performance against budget as and when required;
- 2.12 Report on the activities of all national Judges A & B to PA Management annually, before the AGM of Pistol Australia Inc.; and
- 2.13 Any other such matters or things as are conducive to or incidental to the NRC objectives.

3. Meetings:

The business of the NRC will be conducted at an Annual Meeting and such other meetings as required:

- 3.01 At any Meeting of the NRC, the Director shall be Chairman. In his absence, a Chairman may be elected from those present;
- 3.02 Business at any NRC Meeting may be decided by a simple majority vote, the Chairman shall have an additional casting vote;
- 3.03 All business at any NRC meeting shall be minuted and copies circulated within 21 days to the NRC and to the PA Secretary; and
- 3.04 No meeting of the NRC shall occur unless a majority of elected members are present.

4. Miscellaneous:

The Jury at national pistol shooting championships will be selected by the Director of the NRC.

Amendment to these Regulations will be by way of recommendation to the PA Management Committee.
